

alDentix Terms of Service for End Users

By clicking "Agreed," "Begin Verifying", "Start Verifying" or similar actions, or by using the alDentix Services, you agree to enter a legally binding contract with alDentix (the "Service Provider") for the purpose of using the alDentix digital identity verification and KYC service (the "Service"). If you do not agree to these Terms, do not click "Agreed" (or similar), and do not access or otherwise use any of our Services.

I. General Terms

If you proceed (by clicking "Agreed" or similar, or by using the Services), you acknowledge that you have read, understood, and agree to be bound by all the terms of these Terms of Service, as well as the policies referenced herein, including our <u>Privacy Policy</u> and <u>Consent to the Processing</u> of Biometric Data and Automated Decision-Making during Digital Identification via alDentix.

These Terms of Service apply to the identity verification and KYC services provided by "alDentix" ltd., a Bulgarian company registered in the Commercial Register at the Registry Agency under UIC 204788710, with mailing address: 5A Baku str, floor 6, 1700 Sofia, Bulgaria, email: office@aidentix.com ("alDentix", "Service Provider", "we," "us," or "our") to you, the individual ("End User") or organization ("Corporate Client" or "Client") entering into this contract for the use of these Services.

II. Our Service

Introduction to the Service

- 1. alDentix provides users with a method to remotely verify their identities. You are receiving this Service because a Corporate Client has requested identity verification services from alDentix. alDentix acts as a Data Controller and determines the purposes and means of processing your personal data for this verification.
- 2. The Client has engaged alDentix to perform identity verification services for the purpose of digital identification, and you, as the End User, are participating in this process on behalf of the Corporate Client.

Identity Verification Process

- 3. alDentix will verify your identity through a process called digital identity verification.
- 4. As part of the identity verification process, alDentix may request certain information from you, including:

- Your name
- Personal Identification Number (PIN)
- Date of birth
- Government ID number (such as passport, ID card, or similar)
- Other personal information as outlined in our Privacy Policy
- 5. alDentix may also collect data from your identity document using an **NFC** (**Near Field Communication**) chip. The NFC chip contains personal information encoded on it, which will be "read" by the alDentix Service as part of the verification process.

Authorization to Use Information

- 6. By providing alDentix with your personal information, including biometric information (such as facial images or video for liveness detection), you agree and authorize alDentix to:
- Use this information to verify your identity.
- Share this information with third-party service providers who assist in the identity verification process.

Sharing of Information with Corporate Clients

- 7. Once the digital identification process is complete—whether approved, rejected, or cancelled alDentix may share verification results, including your personal data, with the Corporate Client that requested the verification. The Corporate Client shall be responsible for its own processing of this data, in compliance with its privacy policies and applicable laws.
- 8. The Corporate Client may use this information for its own purposes, in compliance with its privacy policies and applicable laws. We recommend that you review the privacy policy of the Corporate Client to understand how they process your data.

Data Privacy and Protection

- 9. alDentix processes and protects your personal data in accordance with its Privacy
 Policy and in accordance with applicable data confidentiality laws.
- 10. For further details on how your personal data is shared with the Corporate Client or third-party service providers, please refer to our **Privacy Policy**.

Use of Collected Data for Verification Against Official Databases

11. Automatic Comparison with Official Data Controllers: Where technically feasible, alDentix, on behalf of the Corporate Client, may automatically compare the personal



- and biometric data provided during the identity verification process against data held by official data controllers, such as the authority that issued the personal identification document (e.g., passport, ID card, or other identity document).
- 12. **Purpose of Comparison:** The purpose of this automatic comparison is to enhance the accuracy and reliability of the identity verification process, and to verify the authenticity of the submitted identity document and personal information.
- 13. **Scope of Data Used for Comparison:** The data that may be used for automatic comparison includes:
- Personal data (full name, date of birth, PIN, nationality, and document number)
- Biometric data (facial geometry extracted from the selfie or video provided)
 - 14. Access to primary data controllers or government databases: This process will only be undertaken in accordance with applicable laws and regulations, and only when alDentix is permitted to access such primary data controllers or government databases.

III. Fees

- 15. alDentix does not charge you, the End User, any fees for the use of the identity verification Service.
- 16. The Corporate Client that has contracted with alDentix for the digital identification services is responsible for any applicable fees as per their agreement with alDentix.

IV. Data Controller and Data Processing

- 17. alDentix acts as a Data Controller when providing identity verification services. This means we determine the purposes and means of processing your personal data in accordance with applicable data protection laws, including the GDPR. If necessary, we may share your personal data with the Corporate Client.
- 18. alDentix processes and collects your personal data solely for the purpose of providing the identity verification service requested by the Corporate Client.
- 19. As a Data Controller, alDentix is responsible for responding to requests regarding your personal data, including access, correction, deletion, or objection to processing. If you wish to exercise your rights under GDPR, please contact us at privacy@aidentix.com. If your request concerns data processed by the Corporate Client, you should direct your request to them.



V. Representations and Warranties

By agreeing to this contract and using the alDentix identity verification services, you represent and warrant that you:

- 20. **Identity Confirmation**: Are the individual identified in the identity documents that you provide through the Service.
- 21. **Accuracy of Information**: All information you provide is accurate, truthful, and up-to-date.
- 22. Age Requirement: not applicable.
- 23. **Legal Compliance**: Will comply with all applicable local, national, and international laws, EU privacy legislation, regulations, treaties, and conventions that relate to your use of the alDentix Service, including but not limited to data privacy laws and identity verification regulations.

VI. Restrictions

By agreeing to this contract, you warrant that you will NOT use the alDentix Service for any purpose that is not permitted by law and authorized by alDentix, including commercial, competitive, or unlawful purposes. In particular, you must NOT:

- 24. False Identity Claims: use a false identity or impersonate another person.
- 25. Use a false phone number or false information relating to your mobile number, or provide your mobile number to third parties in connection with the Service. You understand and agree that false information related to your mobile number and operator may prevent the Service and identification from working, in which case alDentix shall not be liable for the identification results provided.
- 26. **Unlawful representation:** Falsely claim that you are associated with any person, company, or organization that you are not lawfully affiliated with.
- 27. **Unauthorized Information Collection**: Collect information about alDentix or its Service without alDentix's written consent.
- 28. **Service Modification**: Modify, frame, render (or re-render), mirror, truncate, inject, filter, or otherwise alter or change any content or information contained in the Service without alDentix's written consent.
- 29. **Automated Tools**: Use any automated tools or techniques, including deep-linking, page-scraping, robots, crawlers, indexing, spiders, click-spamming, macro programs, Internet agents, or other algorithms or methodologies to:
- Use, access, or copy the Service.

- Acquire or collect information from the Service.
- Generate impressions or clicks.
- Input or store information.
- Search, generate searches, or monitor the Service or any portion thereof.
- 30. **Circumvent Security Measures**: Attempt to circumvent any security measures implemented by alDentix that are aimed at preventing violations of these Terms of Service or unauthorized use of the Service.

VII. Changes to Terms of Service

- 31. alDentix reserves the right to modify these Terms of Service or its policies related to the Services from time to time.
- 32. You are encouraged to periodically visit this page to review the most current version of the Terms of Service, as they are binding on you.
- 33. If alDentix makes material changes to these Terms of Use, alDentix will notify you of such changes by email to the email address you provided to us or to the Corporate Client, if you have provided one.
- 34. If you object to any changes, you have the right to terminate your contract with alDentix at any time. Your continued use of the Services after any changes become effective will constitute your acceptance of the revised Terms of Service.

VIII. Suspension or Termination of Services

- 35. **Service Suspension:** alDentix reserves the right to suspend the Services at any time. We may suspend the Services for reasons including but not limited to:
- To deal with technical issues or make minor technical updates.
- To update the Services to comply with changes in relevant laws and regulatory requirements.
- To make changes or improvements to the Services.
- If we suspect fraud or potential harm to you, alDentix, or other users of our Service.
- 36. **Service Termination:** alDentix may terminate our contract with you for the Services under the following circumstances:
- If we are unable to update the Services to reflect changes in relevant laws and regulatory requirements.



- If we suspect fraud or potential harm to you, alDentix, or other users of our Service at any time.
- If we reasonably believe you have violated these Terms of Service.

IX. Liability

- 37. **Limitation of Liability:** To the maximum extent permitted by law, alDentix and its affiliates, officers, employees, agents, service providers, or auditors shall not be liable for any indirect, incidental, special, consequential, or punitive damages, including but not limited to loss of profits, revenue, business, goodwill, data, or other intangible losses, arising out of or related to:
- Your unlawful use of or inability to use the Services.
- Any errors, irregularities, or inaccuracies in the identity verification process that were not detectable through reasonable use of the Service.
- Unauthorized access to or alteration of your personal data.
- Any interruption or cessation of transmission to or from the Services caused outside the sphere of influence of aiDentix.
- Any bugs, viruses, trojan horses, or similar that may be transmitted to or through the Services by any third party.
- Any third-party conduct, content, or failure to comply with their obligations.
- 38. **Maximum Liability**: In no event shall the maximum total liability of alDentix for all claims arising out of or related to these Terms, the use of the Services, or the performance of alDentix, exceed **fifty euros (€50)**, regardless of the amount of fees paid by the Corporate Client to alDentix for the Services.
- 39. **Exclusion of Certain Warranties**: The alDentix Services are provided on an "as is" and "as available" basis without warranties of any kind, whether express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, non-infringement, or arising from a course of dealing or usage of trade.
- 40. **No Liability for Third Parties**: alDentix shall not be liable for the actions, content, or services provided by third parties, including but not limited to Corporate Clients, service providers, and data processors assisting with identity verification.
- 41. **Indemnification**: You agree to indemnify, defend, and hold harmless alDentix, its affiliates, and its respective directors, officers, employees, and agents from any and all claims, damages, losses, liabilities, and expenses (including reasonable attorneys' fees) arising out of or related to:



- Your breach of these Terms of Service.
- Your use of the Services.
- Any violation of applicable laws or regulations in connection with your use of the Services.
- Any unauthorized use or access of the Services by you or any third party using your credentials.
- 42. **No Liability for Force Majeure Events:** alDentix will not be held liable for any delay or failure in the performance of the Services due to causes beyond its reasonable control, including but not limited to acts of God, war, terrorism, natural disasters, interruptions in telecommunications, failure of internet service providers, or other events of force majeure.
- 43. **Limitation of Actions**: You agree that any claim or cause of action arising out of or related to the use of the Services or these Terms of Service must be filed within the statutory time limit after the event giving rise to such claim or cause of action occurred, otherwise such claim or cause of action will be forever barred.

X. Jurisdiction

- 44. **Governing Law:** These Terms of Service, as well as any disputes, claims, or controversies arising out of or relating to the use of the Services or the interpretation, performance, or breach of these Terms, shall be governed by and construed in accordance with the laws of Bulgaria. It shall be your responsibility to ensure that your use of the Services complies with the laws and regulations applicable in the Republic of Bulgaria or in your jurisdiction.
- 45. **Exclusive Jurisdiction and Venue**: Any legal action or proceeding arising out of or relating to these Terms of Service shall be brought exclusively in the competent courts in Sofia, Bulgaria, and both parties consent to the jurisdiction and venue of such courts.
- 46. **Compliance with Local Laws**: You agree to comply with all applicable local, national, and international laws and regulations related to the use of the Services. It is your responsibility to ensure that your use of the Services complies with the laws and regulations applicable in the Republic of Bulgaria or in your jurisdiction.

XI. Miscellaneous

47. **Intellectual Property Ownership:** As between you and alDentix, alDentix owns the App and all copies, improvements, modifications and derivative works thereof, and all intellectual property rights relating thereto are and shall remain the exclusive property of alDentix.

- 48. **Entire Agreement:** These Terms of Service constitute the entire agreement between you and alDentix regarding the use of the Services. This agreement supersedes all prior agreements, understandings, or communications between us, including any conflicting or additional communications made before you agreed to these Terms.
- 49. **Severability:** If any provision of these Terms of Service is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions will continue in full force and effect.
- 50. **No Relationship**: No joint venture, partnership, employment, or agency relationship exists between you and alDentix as a result of these Terms of Service.
- 51. **Assignment:** You may not assign or transfer these Terms of Service to anyone without prior written consent from alDentix. Any attempt to assign or transfer these Terms without such consent will be considered void and unenforceable.
- 52. **Non-Waiver**: If either you or alDentix fails to enforce any right or provision under these Terms of Service, it does not mean that the right to enforce such terms has been waived.
- 53. **Written form**: The requirement for written form shall be deemed fulfilled by sending an email, or, if applicable, by SMS, WhatsApp message, Viber message, or by pressing a virtual button or ticking a box (checkbox) in the Application, provided that the statement is technically recorded in a manner that allows its reproduction.
